1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. **WB3793-690/06 of November 16, 2006**.

2. The *Romanian Government* has received a loan from the *International Bank for Reconstruction and Development/International* toward the cost of *Judicial Reform Project*, and it intends to apply part of the proceeds of this loan to payments under the Contract for Procurement of furniture for 6 courts.

3. The *DIEFP* now invites sealed bids from eligible and qualified bidders for procurement of furniture for 6 courts (Maramures Tribunal, Viseu de Sus First Instance Court, Blaj First Instance Court, Vatra Dornei First Instance Court, Bolintin Vale First Instance Court and Saliste First Instance Court). The furniture will include **office furniture** such as desks (big desk, small desk, computer desk, connection pieces), chairs for judges, prosecutors, clerks, attorneys, visitors, tables (council table, meeting table, library table, attorney study table) and **customized furniture for court rooms** such as Judge Panel desk, Judge Panel chairs, Chairs for prosecutors, clerks, attorneys, Witness desk etc., Prisoners box furniture (bench), 4-chair module for session room. All pieces of furniture shall be delivered and installed at each beneficiary court headquarters mentioned above.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.⁵

5. Interested eligible bidders may obtain further information from *DIEFP*, Mrs. *Adriana-Victoria Gheorghiu*, adriana.gheorghiu@just.ro and inspect the Bidding Documents at the address given below from 9.30 AM to 5.00 PM hours (local time).⁶

6. Qualifications requirements include:

(a) Financial Capability

The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

1) Bidder`s average net profit on the last three (3) years (2007, 2008, 2009) must be positive.

2) Minimum average annual turnover, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2007, 2008, 2009) shall be:

- 200,000 EUR for each separate Lot
- 1,200,000 EUR aggregate for all 6 Lots

(b) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

1) The Bidder (company or members of a JV together) finalized during the last three (3) years at least 1 contract in the field of goods delivery, with a value of minimum:

- 200,000 EUR for each separate Lot

- 1,200,000 EUR for all 6 Lots as a whole
- (c) The Bidder shall furnish documentary evidence to demonstrate that the Goods it offers meet the following usage requirement:
- Comply with the Technical Specifications listed in "*Section VI Schedule of Requirements, point 3 Technical Specifications*"

A margin of preference for certain goods manufactured domestically *shall not* be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents (printed copy and CD) in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee of **EURO 50** or RON equivalent at the National Bank of Romania official exchange rate valid on payment day.
