Assignment Title: Consultancy services – Independent external evaluation of on-going works contracts within JRP

The Ministry of Justice has received financing from the World Bank toward the cost of the Judicial Reform Project, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) are aimed to perform for the Ministry of Justice an independent external evaluation of the remaining works part of Judicial Reform Project, which are under various stages of implementation, aiming at providing recommendations regarding their successful completion. The Consultant will provide the following services:

- Asses the technical and financial status of the remaining works part of Judicial Reform Project, under various stages of implementation, together with the PMU technical staff, supervision Consultants, Designers, Contractors;
- Visit the on-going works sites, to check the realities and the current status of the works;
- Identify and asses all the various constrains (i.e.: time, technical, financial estimations, budgetary allocation and of any other nature) which could unfavourably impact the works completion;
- Perform, for the Ministry of Justice top management, an overall independent external assessment report of the remaining works part of Judicial Reform Project, and provide recommendations regarding the financial estimation for their successful completion.

The Consultant is expected to carry out the assignment until March 31, 2015, including one month for final report review and approval. The estimated input of the Individual Consultant is of maximum 3 staff months on request. The Consultant will be mobilised, in writing, independently for each works contract, to perform assessments and will be paid only for the input spent.

The Ministry of Justice now invites Individual Consultants (“Consultants”) to indicate their interest in providing the Services, by sending their Curriculum Vitae at the address below. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services, respectively:

Qualifications and skills:

- Higher education degree in civil construction field;
- Management of works/contracts skills;
- MS Office computer skills (at least Word, Excel).

General professional experience:

- General professional experience of minimum 10 years;

- Working experience in the field of design contracts implementation.

Specific professional experience:

- 10 years of demonstrated working experience in the field of works contracts implementation;
- Proven working experience in at least 3 works projects;
- Proven experience related to the design phase of a works contract;
- Proven expertise in construction works for the strengthening of old buildings/structures;
- Direct experience in FIDIC Conditions of Contract.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants by World Bank Borrowers*, May 2004, revised October 1, 2006 and May 1, 2010 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

A Consultant will be selected in accordance with the Selection of Individual Consultants (SIC) method set out in the Consultant Guidelines. Following the evaluation of the CVs, the selected Consultant will receive a Letter of Invitation together with the Terms of Reference based on which they will submit the Financial Proposal and will be invited for negotiations of the contracts.
