The Government of Romania has received a loan from the International Bank for Reconstruction and Development toward the cost of the Judicial Reform Project, and intends to apply part of the proceeds of this loan to payments under the Contract: ***Civil Works for new construction # Iasi Palace of Justice, # IBRD4811RO-MoJ/W2-1.***
3. The Ministry of Justice through the Department for Implementation of Externally Financed Projects (DIEFP) serves as the implementing agency for the project and now invites sealed bids from eligible and qualified bidders for ***Civil Works for new construction # Iasi Palace of***

**Justice.** The delivery/construction period is **24 months**.

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits (May 2004, Revised October 2006 & May 2010)*, and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
