1. The Government of Romania has received a loan from the International Bank for Reconstruction and Development (IBRD) toward the cost of the Judicial Reform Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for ***Civil Works for the Extension of the Dolj Tribunal (Dolj Tribunal and Craiova Court of Appeal)***

2. The Ministry of Justice through the Department for Implementation of Externally Financed Projects (DIEFP) now invites sealed bids from eligible bidders for the Extension of the Dolj Tribunal (Dolj Tribunal and Craiova Court of Appeal) ("the Works").

A complete set of bidding documents in *English language* (printed copy of Bidding Document and of the volume Bill of Quantities and CD containing: (i) the volumes Specifications and Drawings and (ii) the editable versions of the Bidding Documents and Bill of Quantities) may be acquired by interested bidders upon the submission of a written application to the address below, starting with **August 26, 2013**. In case of conflicting contents, the printed version will prevail over the electronic one.

The Bidding Documents will be sent by courier paid by the interested bidder or handed over to the bidder or his authorized representative.

5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Documents: Procurement of Works*.

6. Bids must be delivered to the address below on or before **October 14, 2013, 12⁰⁰ hours local time** and must be accompanied by a **bid security of EUR 200,000 (or equivalent LEI 910,000)**. Electronic bidding *shall not* be permitted. Late bids will be rejected.

6. Bids will be opened in the presence of bidders' representatives who choose to attend at **October 14, 2013, 12⁰⁰ hours local time** at the address given below.
